The EOIs will be evaluated based on the complete information provided by the firm/company.
- 4. Each project reference as mentioned in section E of the EOI form should be substantiated with a corresponding document. The substantiating document can be in the form of contract agreement/completion certificate or any other document issued by the respective client. Non-compliance to meet the requirement may lead to deduction of marks of the firm for technical competence.
- 5. Consultants may associate with other consultants to enhance their qualifications. However, consulting firms under a Joint Venture (JV) shall submit only one EOI, either as lead member or as a partner of a JV. An Agreement along with Power of Attorney in case of a JV will be required.
- The EOI must be submitted online via ADBs Consultant Management System (CMS) on or before 27 December 2023.
- 7. The consulting services contract award and signing will be subject to ADB's approval.
